# 3DA teams with MEMKO

- Amaero subsidiary, Amaero Engineering Pty Ltd, has entered a Teaming Agreement with MEMKO Aviation Aerospace Defence Pty Ltd to jointly market and provide their engineering and manufacturing services to third parties for projects in the fields of design, manufacturing and certification of products for aviation, defence and space applications.

#### Summary of the key terms of the Teaming Agreement

#### **Parties**

Amaero Engineering Pty Ltd (ABN 46 162 732 649) and MEMKO Aviation Aerospace Defence Pty Ltd (ABN 73 619 452 470)

#### Term

5 years unless terminated and standard termination clauses exist for both parties, which can be actioned in the case of breach of contract.

#### **Teaming Project**

Means the joint marketing and provision by the parties of their engineering and manufacturing services to third parties for projects in the fields of design, manufacturing and certification of products for aviation, defence and space applications.

# Significance of the Teaming Agreement

The Company acknowledges that whilst the Teaming Agreement is not commercially material to the Company in the immediate term, it does expect revenue to be generated from supply contracts in the future and the market will be updated as material supply contracts are entered into.

Means the 5 Eyes Countries (Australia, New Zealand, USA, Canada and UK) plus India and Singapore.

The Agreement does not transfer any interest in intellectual property rights.
